Key Duties & Responsibilities

- Monitor SZV-insured persons for illness, disability, and treatment progress, advise employers on employees' work ability, and manage medical records. Assess disability claims, determine industrial accidents, and authorize specialist care as needed.
- Review and approve authorization requests, including specialist and paramedical treatments, medications, and reimbursements for local and overseas treatments.
- Fulfill on-call responsibilities during vacations and holidays, handle emergencies, and coordinate with the Governor's Office for uninsured or illegal patients.
- Review and approve medical referrals abroad for specialized treatments that are not available locally by approving destinations and necessary care.
- Liaise with healthcare providers, promote savings in medical costs, provide health education, conduct presentations, assist in appeals, and adhere to departmental procedures.

Knowledge & Skills

- Knowledge of the medical portion of health insurance coverage.
- Knowledge of occupational and insurance medicine.
- Knowledge of social legislation.
- Excellent verbal and written communication skills in English and Dutch.

Education & Experience

- Valid Ministerial decree (BIG-registration/Uni-Code).
- Doctorate in Medicine, Insurance, or Occupational Doctor.
- Specialization training of at least two (2) years in insurance or occupational medicine.
